Meeting of February 8, 2023

This telephonic/video meeting, held in compliance with Alameda County's shelter in place order, was called to order on February 8, 2023, at 6:30 p.m. by President Lily Mei using a Zoom software interface.

1. Roll Call

5. Public Comments and Other Announcements

Mayor Ezzy Ashcraft introduced Amy Wooldridge, the City of Alameda's new Assistant City Manager.

Ryan-Thomas Brown, Deputy District Director from Congressman Mark De Saulnier's office, introduced himself to the membership.

Mayor Hannon requested that the meeting be adjourned in memory of the late Supervisor Richard Valle, who passed away today.

6. Member Reports on Regional Activities and Committees

Mayor Arreguin said he was appointed to Bay Conservation Commission and will be looking for an alternate. ABAG and MTC are hiring a new executive director, and an appointment is expected shortly. San Francisco Bay Restoration Authority announced the opening for an Alternate member.

John Bauters indicated that the Bay Area Air Quality Management District's management audit is completed and identified a problem in its Human Relations and Finance departments. He noted that corrective actions are in place. He also updated the membership of proposed new NOx emission standards.

Mayor Dutra Vernaci addressed members regarding the Metropolitan Transportation Commission (MTC), including a planned visit to Washington, D.C., to discuss local transportation issues.

7. Appointments to Regional Boards and Call for Applications

President Lilly Mei announced that the Nominating Committee made its recommendations on the applications included in its February 8, 2023, meeting agenda and opened the floor for comments/nominations. Seeing no additional nominations, it was moved by Mayor Marchand and seconded by Mayor Brown that the Alameda County Mayors' Conference and the Alameda County City Selection Committee accept the Nominating Committee's recommendations as follows:

- Reappoint Nina Senn to the Alameda County Commission on the Status of Women for a two-year term expiring in February 2025.
- Reappoint Mayor Mei to the East Bay Economic Development Alliance as the South Region representative for a two-year term expiring in February 2025.
- Appoint Mayor Gonzalez to the Bay Area Air Quality Management District for the partial term vacated by former Mayor Pauline Russo, expiring in February 2025.

The motion was approved unanimously by a roll call vote and so ordered.

8. League of California Cities Report, Legislative Updates and Actions

Samantha Caygill, Regional Public Affairs Manager, East Bay Division, League of California Cities (League), could not attend the meeting.

9. Meeting Presentation

Melissa Willk, Alameda County Auditor-Controller /Clerk Recorder, provided a summary of the responsibilities and services provided by her elected offices, as well as information

on new projects and how her offices and staff work to support cities. She informed members that she and her staff could meet with them to discuss services and answer questions.

There were questions and comments from Mayors Gonzalez, Dutra Vernaci, Salinas, and Hannon.

10. Other Business Matter

- a) Nina Senn and Nancy Bremeau provided information regarding the Convention on the Elimination of All Forms of Discrimination Against (CEDAW) and recommended passage of Alameda County Mayors' Conference Resolution 1.23 A Resolution of the Alameda County Mayors' Conference Supporting the Convention on the Elimination of All Forms of Discrimination Against (CEDAW). Mayors Marchand, Brown, Bauters, and Ezzy- Ashcraft commented on the resolution, and after discussion, Nina Senn agreed to facilitate modifications to the CEDAW and bring it back to the membership at a later date.
- b) The members considered approving and forwarding a letter from the Alameda County Mayors' Conference to the Alameda County Fair Foundation supporting its effort to develop an educational farm on approximately two acres of the Alameda County Fairgrounds. After discussion, it was moved by Mayor Brown and Seconded by Mayor Dutra Vernaci that the letter be approved and distributed as presented.

The motion was approved unanimously by a roll call vote and so ordered.

11. Request for Future Agenda Items

Mayor Salinas offered to have his staff present on work the City is doing regarding reparations.

12. Adjournment

The meeting was adjourned at 7:38 p.m.
