The meeting was called to order by President Salinas on December 10, 2025, at the Patelco Credit Union, 3 Park Place, Dublin, California.

Dan Morely, with Indivisible Tri-Valley, stated his opposition to the U.S. Immigration and Customs Enforcement (ICE) using the former Federal prison in Dublin, and urged the mayors to adopt a resolution opposing such use.

Dave Haubert, Alameda County Supervisor (District-1), welcomed the mayors to Dublin.

Melissa Hernandez, Director, Bay Area Rapid Transit District (BART) (District 5), provided an update on BART activities, including the introduction of the new Clipper card.

Stephen Baiter, Executive Director of the East Bay EDA, announced the upcoming East Bay Innovation Awards event on March 26, 2026, and encouraged members to register.

5. Member Reports on Regional Activities and Committees

Mayor Ezzy Ashcraft provided an update on the Metropolitan Transportation Commission (MTC), stating that Caltrans will activate the toll lanes on I-80 in Solano County beginning on December 16, 2025.

Mayor Gonzalez BAQMD discussed key programs and policies in the Agency's Strategic Plan, including inoperable monitoring equipment, wood-burning fireplaces, and its Commercial Electric Land and Garden Equipment buyback program.
